**AM I ABLE TO ACCESS ALL  
OF MY CREDIT UNION ACCOUNTS?**

Yes, with the exception of Holiday Clubs, IRAs  
and MasterCard. These are restricted accounts.  
The Holiday Club and IRA accounts will only  
be able to be viewed online.

**HOW LONG AM I ABLE TO USE  
CDO ONLINE PER SESSION?**

You have unlimited transactions, but  
if your connection is inactive for 5 minutes,  
your session will automatically log off.

**IS MY INFORMATION SECURE?**

Yes. Ensuring the privacy of your account and personal information is a top priority. We do not store any member information on our web server that is accessible to the public. Layers of security include automatic sign-off, encryption, firewalls and password lock-out.

**\*\*\*Please note: Transfers made via this service are subject to the same Federal Regulation D restrictions as are all other automatic and electronic transactions. Savings accounts are limited to a combined total of 6 such transaction per month. Checking accounts are not limited. All banks and credit unions are subject to this regulation.**
