4. Ask your Guidance Department for a copy of your transcript and SAT or ACT scores. If your transcript does not include a straight (not weighted) grade point average as of the end of 11<sup>th</sup> grade, ask the Guidance Department to add this piece of information to the transcript.

## SCHOLARSHIP PROGRAM 2022

- **The Award**

The Chen-Del-O Federal Credit Union Scholarship is an award of \$500.00 which will be paid directly to the student upon proof of attending their 2<sup>nd</sup> college semester.

- **Eligibility**

The applicant **must be a member** in good standing of Chen-Del-O Federal Credit Union at the time of application and at the time of the award. The member must be a college bound high school senior at the time of application.

- **Application Process**

Eligible members must complete this scholarship application.

Check each task after completion

- \_\_\_\_\_ 1. The application **must** be signed by a credit union management-level employee in order to verify eligibility.
- \_\_\_\_\_ 2. The signed application must be submitted together with:
  - \_\_\_\_\_ A high school transcript.
  - \_\_\_\_\_ An SAT/PSAT/ACT transcript (Obtained through your high school guidance office)
- \_\_\_\_\_ 3. The applicant and his/her parent or guardian must sign the Certification and release Authorization on the back page of this form.
- \_\_\_\_\_ 4. The application, transcript and essay must be returned by the application deadline. If any portion is incomplete or not included, the application will not be considered.

- **Selection Process**

Judging will be based on both subjective criteria and weighted, objective criteria. These include academic performance, essay, community activities and personal goals.

- **Application Deadline**

Application must be returned to the credit union no later than Friday, February 11, 2022.

- **Scholarship Applicant Information**
