- 4. Ask your Guidance Department for a copy of your transcript and SAT or ACT scores. If your transcript does not include a straight (not weighted) grade point average as of the end of 11th grade, ask the Guidance Department to add this piece of information to the transcript.
- 5. Submit all of the information to the Credit Union no later than the close of business on FRIDAY, MARCH 13, 2026. Applications received after this date will not be considered. Emailed copy is ok. abankowski@chendelo.org (no faxes please)

 4.	The application, transcript and essay must be returned by the application
	deadline. If any portion is incomplete or not included, the application will not
