# \*\*Chen-Del-O Federal Credit Union Privacy Notice

Chen-Del-O Federal Credit Union is owned by its members and run by a Board of Directors you elect. You can be confident that your financial privacy is a top priority of this Credit Union. We are required by law to give you this privacy notice to explain how we collect, use and safeguard your personal financial information. If you have any questions, please contact the Credit Union at 607-829-3560.

We are committed to providing you with competitive products and services to meet your financial needs which necessitate that we share information about you to complete your transactions and provide you with certain financial opportunities. In order to do so, we have entered into agreements with other companies that provide either service to us or additional financial products for you to consider. Under these arrangements, we may disclose all of the information we collect, as described below, to companies that perform marketing or other services on our behalf or to other financial institutions with whom we have joint marketing agreements. To protect our member's privacy, we only work with companies that agree to maintain strong confidentiality protections and limit the use of information we provide. We do not permit these companies to sell to other third parties the information we provide them.

#### Information We Collect and Disclose About You

We collect non-public personal information about you from the following sources: From membership and loan application forms, we obtain information such as name, address, social security number and income

\*From your transactions with us or other companies that work closely with us to provide you with financial products and services, we obtain information such as your account balances, payment history, parties to transactions, and credit card usage.

- \*From consumer reporting agencies, we obtain information such as your credit worthiness and credit history.
- \*From verifications of information you provide on applications and other forms, we obtain information from current or past employers, other financial institutions and other sources listed on the application.

We may disclose all of the information that we collect, as described above to companies that perform marketing services on our behalf or to other financial institutions with whom we have joint marketing agreements.

#### Example:

TruStage Insurance Agency offers members Accidental Death & Dismemberment insurance as well as other kinds of insurances. We may also disclose information we collect about you under other circumstances as permitted or required by law. These disclosures typically include information to process transactions on your behalf, conduct the operations of our credit union, and follow your instructions as you authorize, or protect the security of our financial records. If you terminate your membership with Chen-Del-O Federal Credit Union, we will not share information we have collected about you, except as permitted or required by law.

#### **How We Protect Your Information**

We restrict access to non-public information about you to those employees who have a specific business purpose in utilizing your data. Our employees are trained in the importance of maintaining confidentiality and member service privacy. We maintain physical, electronic, and procedural safeguards that comply with federal regulations and leading industry practices to safeguard your non-public personal information.

### **Scholarship Award Program**

Once again, the credit union will be sponsoring a credit union-wide college Scholarship Award Program.

Chen-Del-O FCU members will be competing with other high school seniors from our credit union membership for the chance to win one of three \$500.00 scholarship awards offered. # NO MORE TRANSFER LIMITS ON SAVINGS ACCOUNTS!

EARLY IN 2020, THE FEDERAL RESERVE AMENDED FEDERAL REGULATION D FOR FINANCIAL INSTITUTIONS TO NO LONGER REQUIRE LIMITS ON THE NUMBER OF TRANSFERS MADE FROM SAVINGS ACCOUNTS! THE REGULATION WAS STARTED IN THE 1930S TO ENCOURAGE SAVINGS FOR THE STABILIZATION OF BANKS. TO NO AVAIL, THE BANKING COMMUNITY HAS LOBBIED TO HAVE THIS REGULATION CHANGED OR REMOVED FOR SEVERAL YEARS DUE TO THE INCREASED AMOUNT OF ELECTRONIC BANKING MEANS. THE LIMIT WAS SET TO 6 TRANSACTIONS A MONTH, WHICH, THANKS TO THE COVID 19 PANDEMIC, WAS FINALLY RELEASED DUE TO NEEDING "EASY ACCESS" TO FUNDS BY

ELECTRONIC MEANS. THAT'S ONE GOOD THING THAT CAME OUT OF COVID 19!!

INSTITUTIONS ARE STILL ABLE TO RESTRICT TRANSACTIONS AND CHARGE ACCOUNTS IF THEY CHOOSE TO DO SO. CHEN-DEL-O FCU CHOOSES TO DO NEITHER! WE BELIEVE THAT MEMBERS SHOULD ALWAYS HAVE EASY ACCESS TO THEIR FUNDS AND WE STRIVE TO HELP THEM ACHIEVE THAT WITH OUR MANY ELECTRONIC OPTIONS!
